

5. Candidates applying for re-evaluation shall have to surrender their original marks Certificate and photocopy of marks sheet with other separate application.
6. Candidates are required to use separate application form for each paper.
7. The last date to apply for re-evaluation of answer book of above mentioned course is **13.6.2024**, and your application for re-evaluation should reach the Office of the Controller of Examinations latest by the said date.
